CKC Exhibitor Information

Eligibility

To be eligible to compete in these trials a dog must be 18 months or older and have a CKC Registration number, CCN, MRN, MCN, PEN or a TCN. Bitches in Season are not allowed to compete and will be refunded their entry and listing fees provided a veterinarian's note stating that the female was in season within 10 days before the start of the trial and is submitted to the Trial Secretary on or before the day of the trial.

Listed Dogs

Dogs without an individual CKC registration number must obtain a Temporary Competition Number (TCN). The TCN allows a dog that is eligible for CKC registration or an Event Registration Number (ERN), to participate in CKC events. Temporary Competition Numbers must be obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid.

While there is no fee for the Temporary Competition Number, exhibitors **will still be required to pay listing fees when entering events.**

Non-Member Participation Fee

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC. For the title to be awarded, the non-members will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The Non-Member Participation Fee is a fee paid in the calendar year (Jan-Dec) in which the dog achieved its title(s). Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars at the time of entry.

Important Trial Information



- Flat **ribbons** will be awarded for qualifying scores and for 1st through 4th placements. New title rosettes will be available free of charge. Ribbons are self-serve.
- **Course Familiarization:** Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class. There will be a 5-minute break between the end of the walk-through and the first dog on the line.
- **Equipment Familiarization** will be available for the Novice dogs before the start of the Novice Standard class if requested. Dogs will enter the ring one at a time and do each of the 3 contacts once on or off lead. **No toys or food allowed.**
- **Equipment:** The Table, Teeter, Dog-Walk and A-Frame are all rubberized. Tire is breakaway style. 24" weave poles will be used. Timing is electronic.
- **Photographer** Shelley Victoria Photography will be in attendance.
- **laggy Doggy's** dog treats will be in attendance.
- **Food** trucks and fast food are available off site within a few minutes from the venue.
- **No treats** allowed in the ring. Food cannot be within 10 ft of ring.
- Please **pick-up** after your dogs and do not walk dogs near the kennel.
- **No provision** for inclement weather. Limited shade available.
- **Judging schedule** will be emailed after the closing date. Estimated start time for this trial will be 9:30 am.
- **Move-ups** will be allowed after the closing date and in between trials.
- **Volunteers are necessary to run these events.** Sign-up sheets will be available at the trials. Training provided. **Volunteers have a chance to win a gift graciously donated by OCKC!**
